



Terms & conditions

- 1. The conference fees indicated are the fees per participant.
- 2. Discounts and offers only apply to the full conference fee.
- On receipt of registration the sent invoice shall be paid within 2 weeks.
- Registrations less than 2 weeks prior to the conference will receive an electronic invoice which has to be paid prior to the conference.
- For payments not received within the given time, statutory interest and administration costs of 15% of the original invoice amount will be charged.
- 6. The fees include conference participation (all day), coffee & tea during breaks, lunch, Monday evening dinner and reception.
- 7. Refunds for cancellations will be granted only one month prior to the conference, after receiving your written cancellation.
- All cancellations less than one month prior to the conference will be subjected to a cancellation fee of 50% of the original amount to cover expenses already made. However, you are allowed to send a substitute to replace you.
- 9. Cancellation of a table top reservation will be subjected to a cancellation fee of 50% of the original amount.
- 10. Participants profiles will be published on the conference website and in the conference app.
- The full conference fee will be charged in the case of cancellation or no-show on any of the conference dates.
- 12. Personal information will be held in our database and may be used by Iventus to advertise its products. Occasionally, we may share this information with interested third parties for marketing. If you do not wish to disclose your details to third parties please provide a written statement at the time of registration.
- 13. Participants can be recorded on photo and/or video. The conference organizers have the right to use these captured images for promotion purposes through its own website, social media or other publication channels.
- 14. In the unlikely event of the change of conference dates for any reasons beyond our control, should a delegate wish to withdraw from the conference, the maximum liability to us shall be limited to a 75% refund of the conference registration fee paid at the time of booking, with no additional liability whatsoever to the conference organizers and hosts or any individuals affiliated with the conference in any capacity. We may deduct any additional bank transfer fees associated with the refund.
- 15. In the unlikely event of cancellation of the conference the maximum liability shall be limited to a full refund of the conference registration fee paid at the time of booking, with no additional liability whatsoever to the conference organizers and hosts or any individuals affiliated with the conference in any capacity. We may deduct any additional bank transfer fees associated with the refund.
- 16.
